'We could be twin brothers,' the other man said.

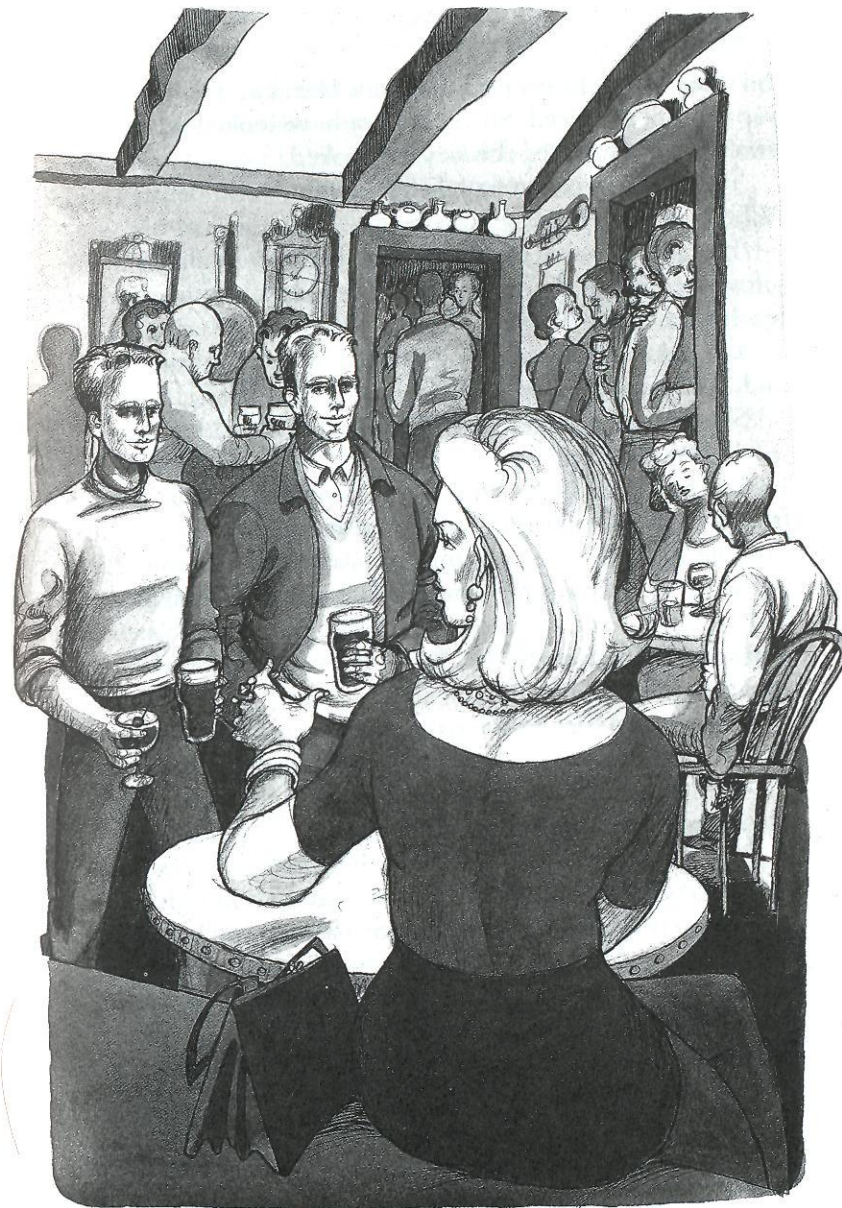
They introduced themselves. The other man's name was John Bentley. He had a soft London accent<sup>4</sup>.

'Have you signed the contract already?' Booker asked.

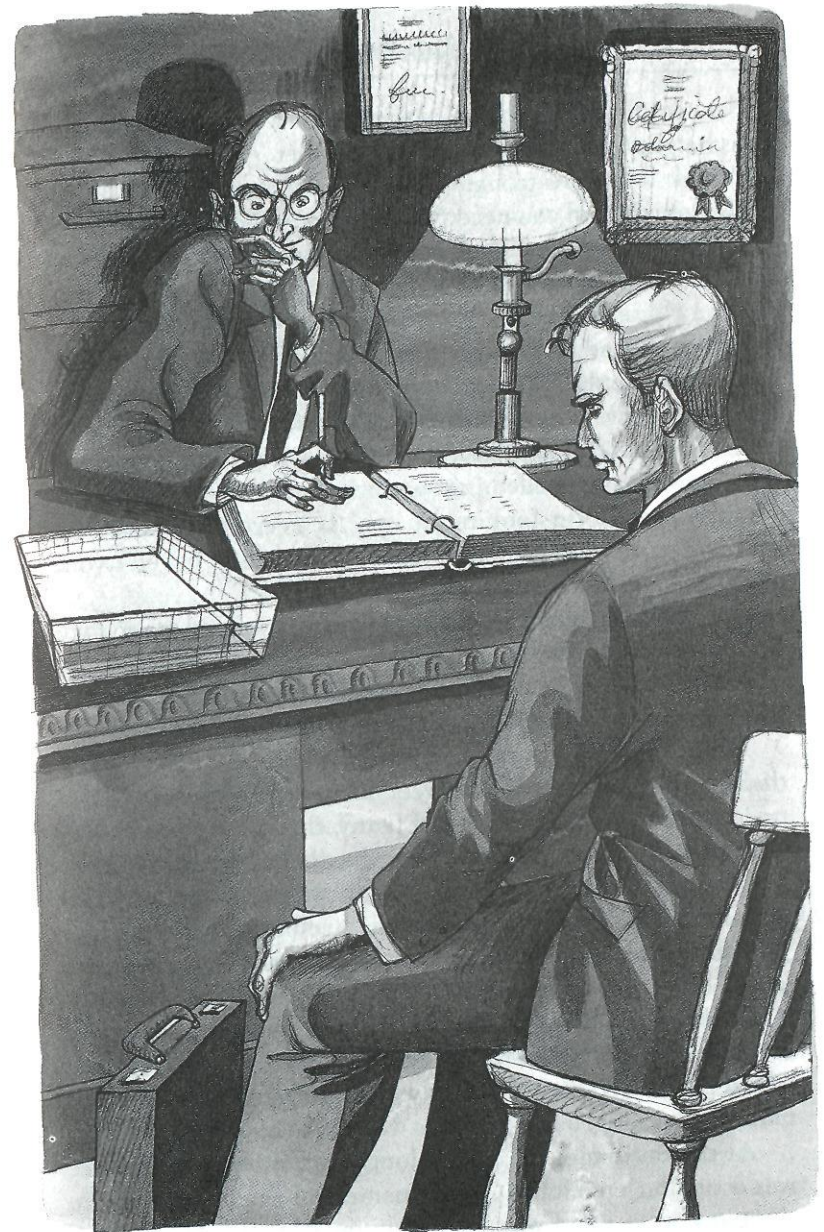

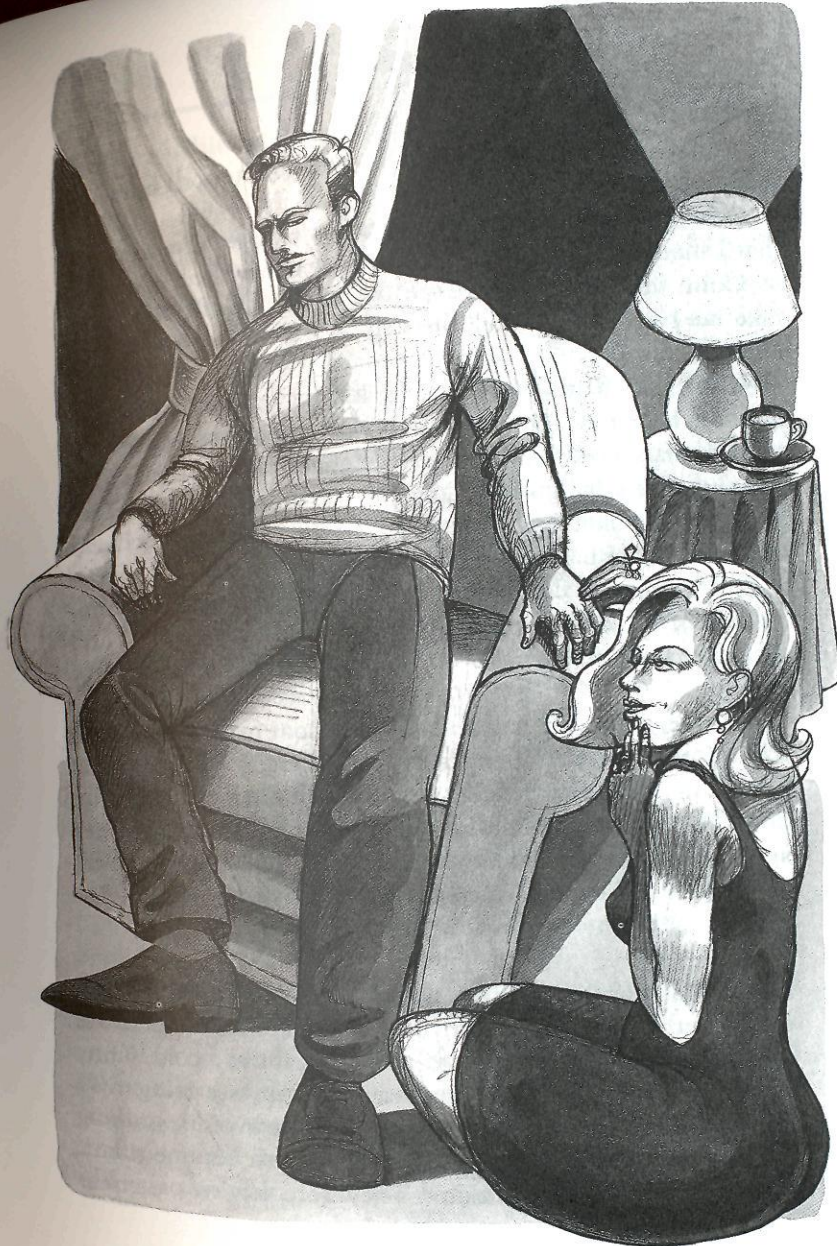

'Yes,' Colin said.

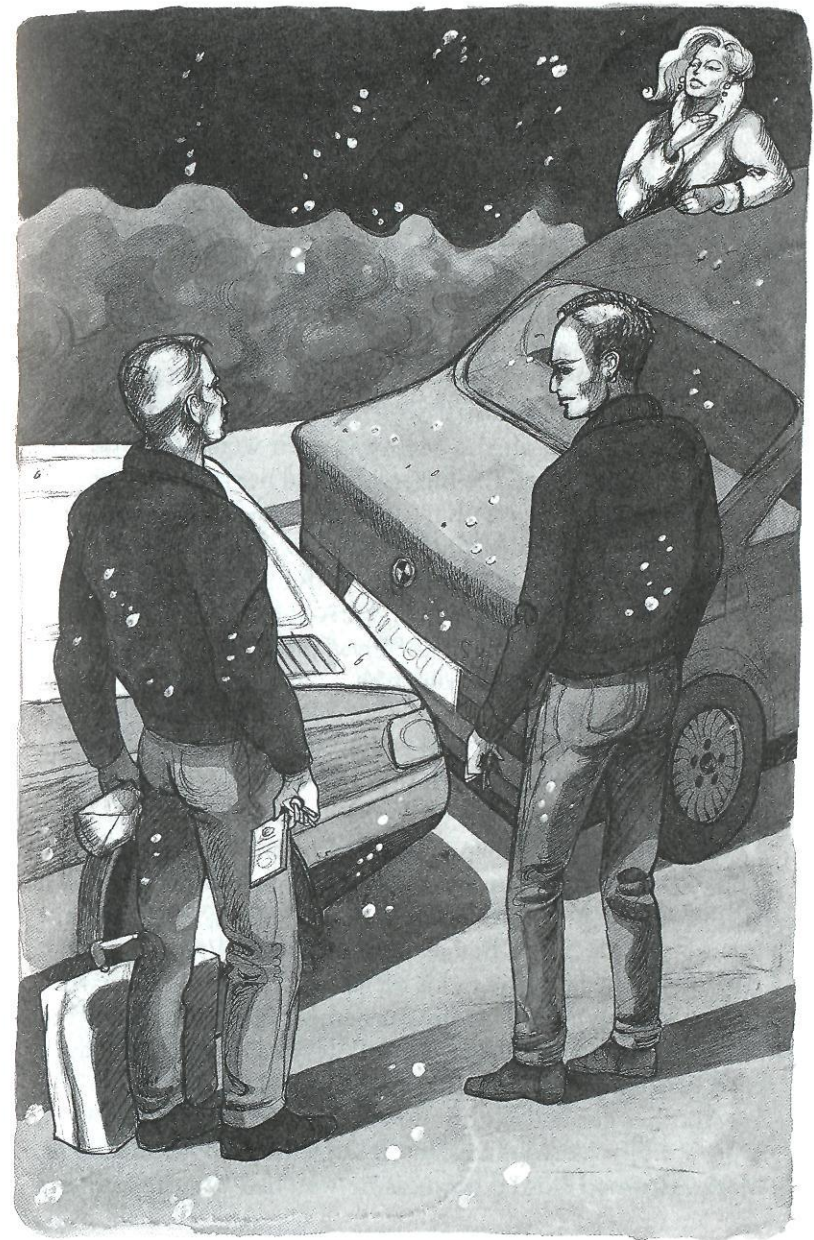
'OK, get your case,' Linda said.

'Where the hell is he?' Julie said to herself.

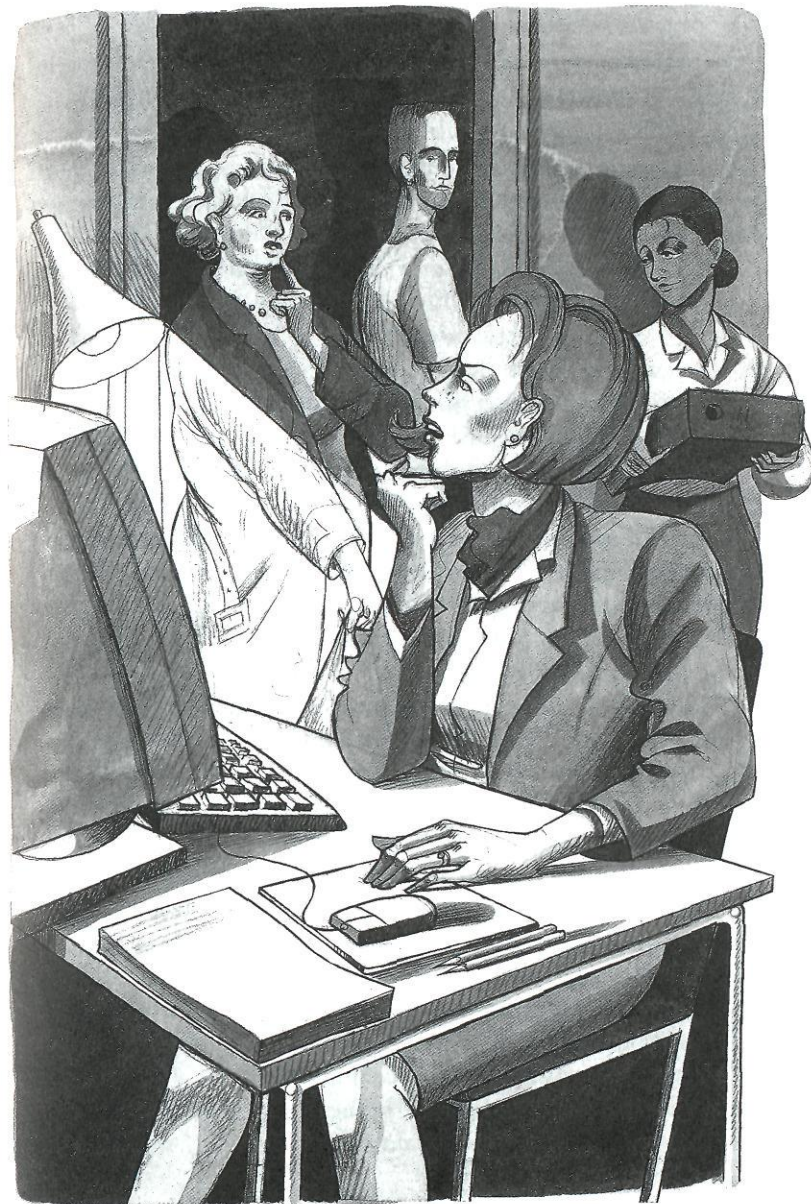
As Julie turned off her computer, Maggie, the company's secretary, was putting her coat on and getting ready to leave the office.

Linda unlocked the front door. 'Come in,' she said.

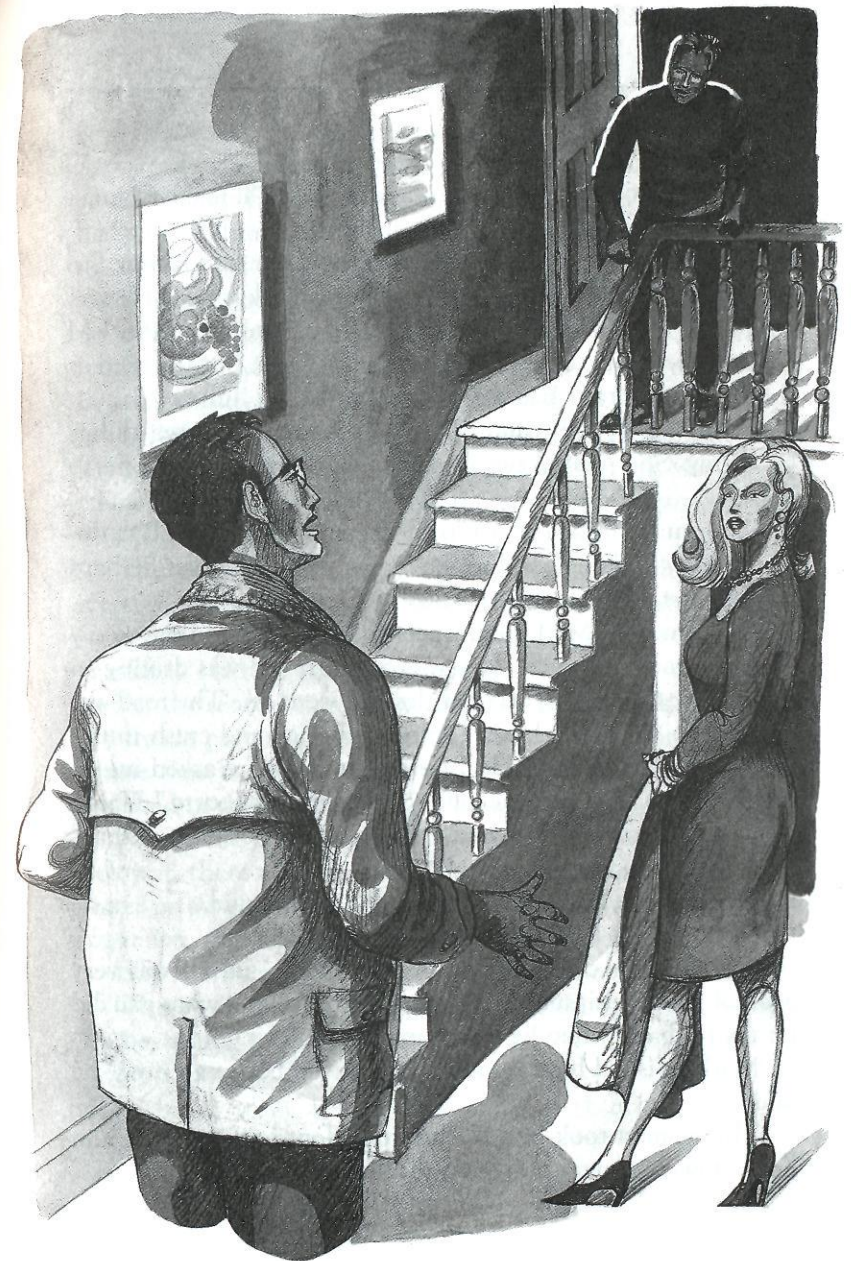
As they stepped into the house, a voice called out, 'Linda, is that you?'

Mark drank some of his coffee. 'No,' he quietly. He knew what the woman was going to say next.

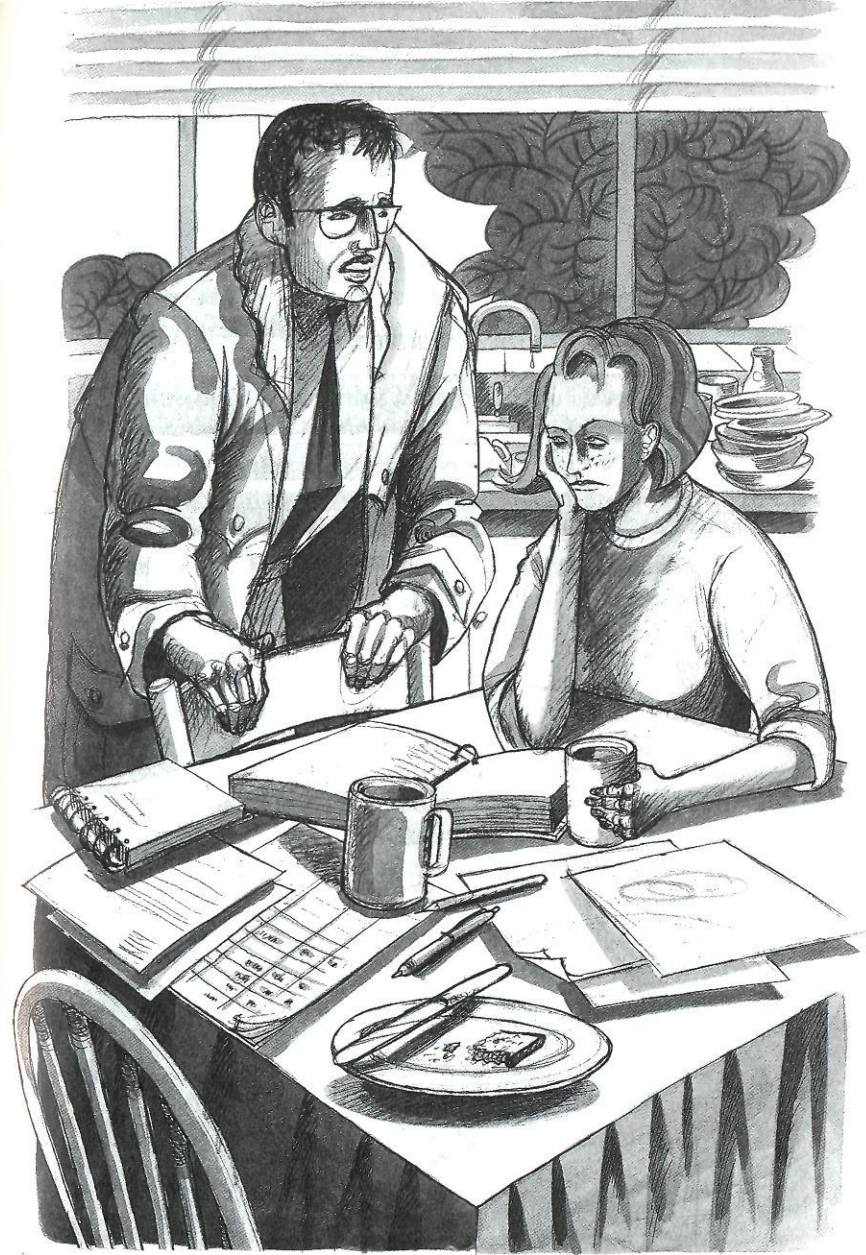
'Ah! No doubt, he'd died in a car accident?' Julie said. She sighed deeply. 'I think you'd better go, Mr Ashwood.'

The corridor led to the shop itself, and to the stairs which went up to the workshop on the upper storey. But half way

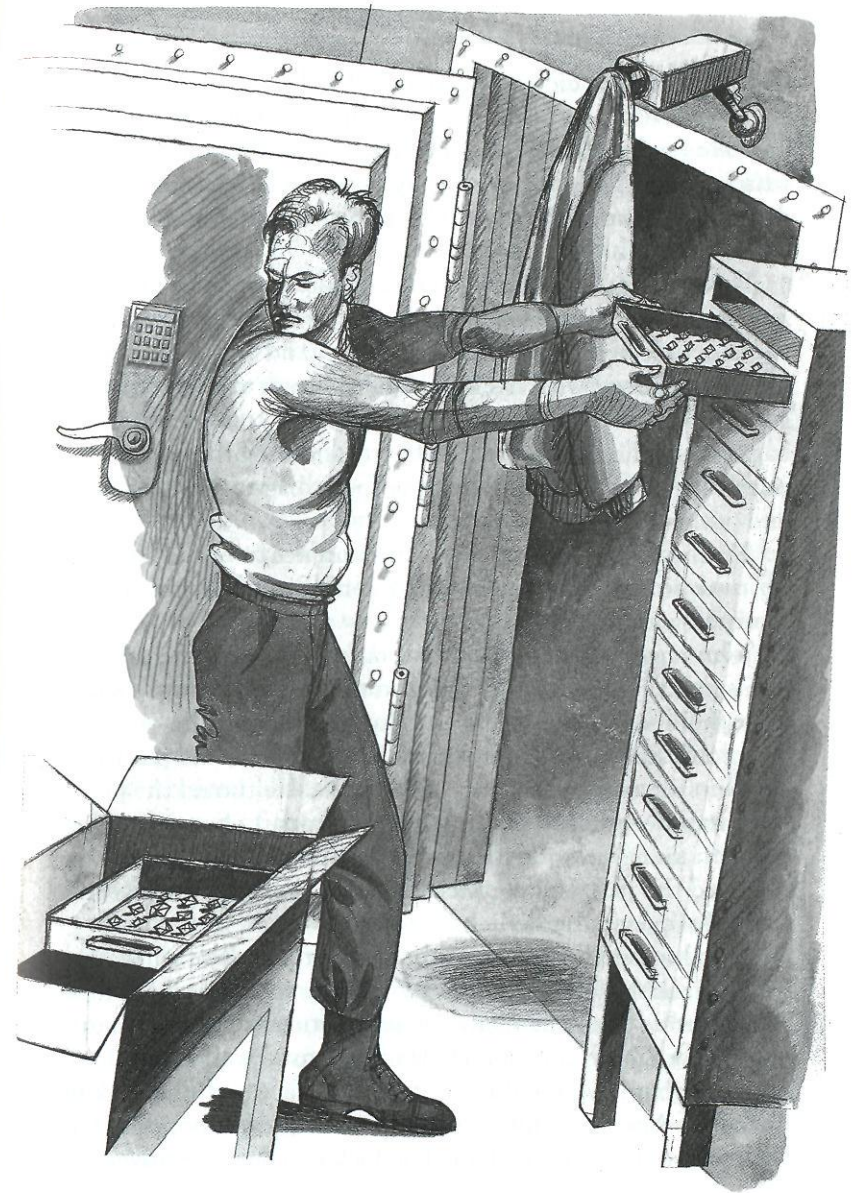

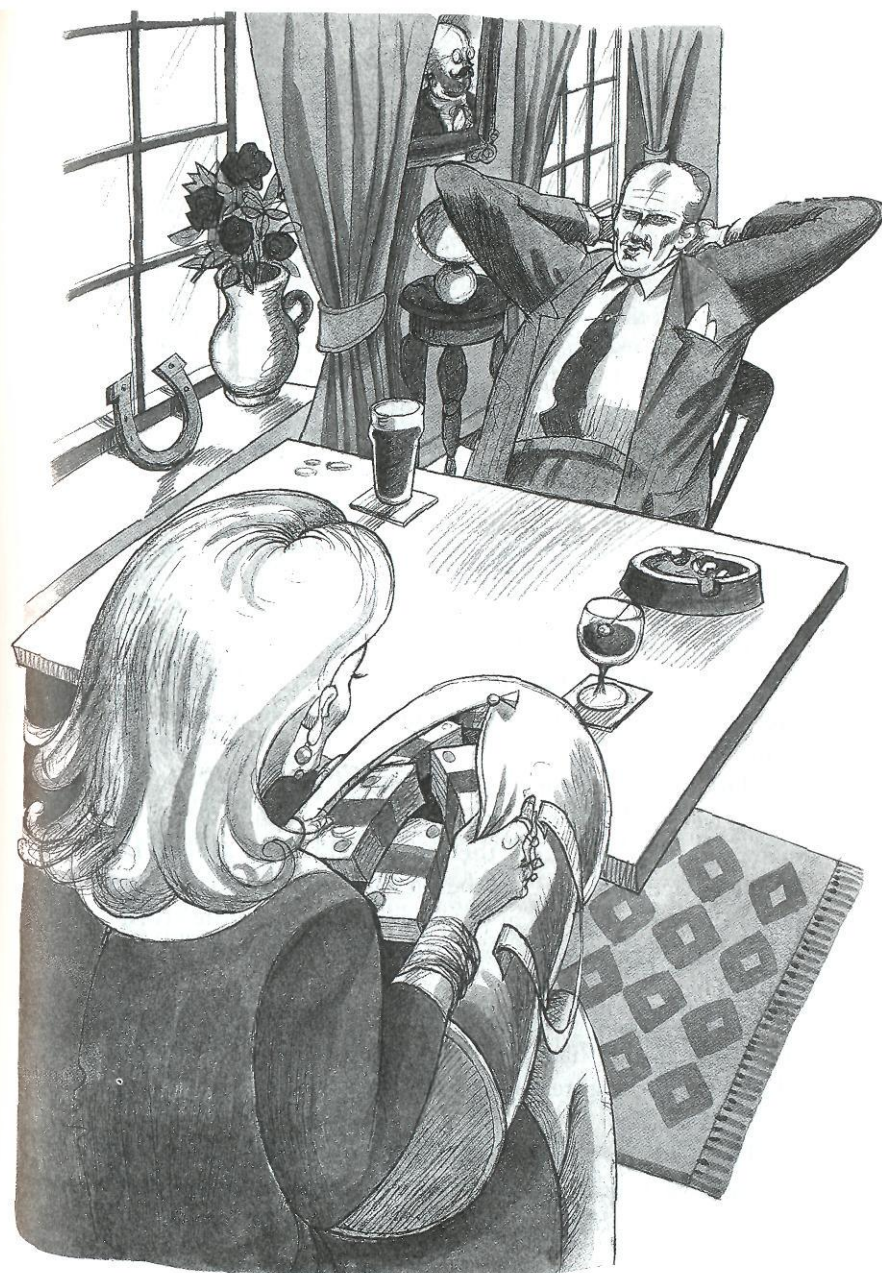

When Mark and Julie were feeling better, a police officer visited them and they both gave him statements about the attack<sup>4</sup>. Mark explained the whole story about Colin Fenton, and John and Linda Bentley. With this information, the police were able to connect Bentley with the robbery at Sandwell's. At first, Mark was surprised that they believed his strange story. But a policeman told him that detectives had discovered that the lock on the skylight in the roof had been broken from the *inside*, not from the outside. Also, there were no footprints on the roof, and in the shop there was a further clue. The way that the broken glass was lying in the display cabinets showed that the jewellery had been removed *before* the glass had been smashed. These clues made the police believe that it was an 'inside job' – that someone who had keys and knew the alarm code had done the robbery. It's good for both of you!

Julie looked thoughtful. She sipped her wine again.

'I think it's a great idea,' she said at last. 'Mark, you're a genius!'

'There's another thing,' Mark went on. 'I think that all of your company's work could be done without an office. Offices are expensive. All you need is the equipment and the staff. Your staff could work at home. You'd obviously need to have regular meetings, but you could organize the work so that your staff can work independently. Your own house could be the company's official address. Your secretary would be in constant touch with you by phone. You'll save a lot of money if you don't rent an office. Your company will soon be earning well again.'

## SECTION 1

*Terms to do with business***arranged a loan** (page 12)

Colin is going to borrow some money from a bank so that he can buy the things that he needs for the company and so he can pay the staff. The bank will *charge interest on the loan*. This extra money will have to be paid after the loan is repaid.

**client loyalty** (page 93)

*clients* pay someone, or a company, to work for them. When clients ask the same company to work for them over many years, these clients are being *loyal* to that company. C.J.F. Software Solutions will earn money regularly if they keep the same clients for many years.

**computer software** (page 5)

*software* is the set of instructions given to a computer that makes it complete its work. Colin is training business people to use the instructions on their computers correctly. He is teaching a *course* in *computer software*.

**confirmed** – *waiting for a valuable contract to be confirmed* (page 56)

Colin is waiting for one of the companies that he is working for to contact him. Colin's company has developed some *software* (see above) for this company. When the company agrees to Colin's price for the work, they will *confirm the contract* and the agreement will be legal. There has been a lot of work for Colin to do for this contract and he will earn a lot of money from it.

**deal** (page 62)

an agreement between two people, or two companies, that they will do business together.

**discount** – *sell at a discount* (page 94)

sell products for less than their usual price.

**export regulations** (page 43)

the rules that businesses have to follow when they send goods overseas to sell them. The *Department of Trade and Industry* is the section of the British Government which prepares these rules. The department publishes these rules in books. The officers of the D.T.I. make sure that companies follow these rules.



**floppy disks** (page 14)

copies of documents or files from a computer can be stored on these thin, flat pieces of metal and plastic.

**go out of business** (page 12)

to be unsuccessful in business and have to close your company.

**insurance brokers** (page 12)

a company that makes arrangements for *insurance*. People or businesses can be *insured* so that if there is damage to property or someone is injured in an accident, they will be paid some money. To get insurance, a sum of money has to be paid every year to an *insurance company*. *Insurance brokers* find the best prices for this kind of arrangement. Then they make sure that the insurance company pays the person or business that has had trouble.

**licences** (page 93)

special agreements which allow people to use a company's product or idea. The *licence* is the document which describes this agreement. It says how long the agreement will last – the *licence period* (page 93). All computer software (see above) is *licensed* to the people who want to use it. If the computer company develops a newer *version* (page 93) of the software, then the users need another agreement.

**main stock** (page 76)

goods that are to be sold. The *main stock* in Sandwell's is the expensive jewellery which is put in the strong-room every night.

**profits** (page 43)

the money that a company earns after all the expenses have been paid.

**programmers** (page 14)

people who work with computers. *Programmers* prepare the instructions that make computers complete different types of work.

**raise that much cash** (page 62)

Frankie is saying that it will be difficult for him to sell a million pounds' worth of stolen jewellery quickly. He will have to speak to many people before he has sold all the jewellery and has got the money.

## SECTION 2

### *Terms to do with crime and criminals*

**a chance to live an honest life** (page 17)

the manager at Sandwell's thought that John was not going to steal again. He gave him a job so that he would be able to earn money honestly and he would no longer be a criminal.

**alibi** (page 23)

if you are accused of a crime and you can prove to the police that you were not where the crime took place, this is an *alibi*. If someone can also tell the police that your information is correct – prove that your story is true – they can *provide you with* or *give you an alibi* (page 26).

**attempted murder** (page 95)

when someone tries to kill another person but does not succeed, this is the crime of *attempted murder*.

**break-in** (page 24)

when somebody gets into a house, shop or office building by breaking a door or a window and steals something.

**charged** (page 95)

when criminals are arrested by the police, they are *charged*. They are told what their crime is and they are later taken to court.

**criminal record** (page 24)

the details – the *record* – of all of a criminal's crimes are kept by the police.

**fence** (page 27)

a criminal *fences* – buys or sells stolen things – to or from another person. The criminal who buys or sells these things is called a *fence* (page 79).

**plastic explosive** (page 78)

a soft material that is pushed onto wood, metal or stone to break them apart with an explosion. A *detonator* (page 78) has to be put into the material to make it explode. The detonator explodes using electricity. A *timer* (page 78) is used so that the explosion happens at a particular time. John has to *set the timer of the detonator* (page 78) carefully so that the plastic explosive breaks open the lock of the door at the right time.

**security systems** (page 24)

equipment that is put into shops, houses or offices to stop thieves stealing things from them. The *alarm* (page 24) usually has *bells* (page 75) which ring if someone breaks a window or an outside door. Shops or banks often have alarm bells which will ring at the

nearest police station if someone tries to get into the buildings. Security systems work using electricity. Secret numbers – a *code* (page 75) – are put into the device by using a *keypad* (page 75). A keypad looks like the front of a calculator. When the code is entered on the keypad and the system is switched on, the security alarm is working. The code number has to be re-entered on the keypad to turn the security system off.

In Sandwell's shop there is an *electronic combination lock* (page 76) on the door of the strong-room. The heavy, powerful lock opens and shuts using electricity. There is no metal key for the lock. The door is locked and unlocked when secret numbers are entered on a keypad. If the door is opened, the lock has to be *reset* (page 78) to make it safe.

***small-time thieving*** (page 9)

Linda is saying that John will no longer be stealing small amounts of money or less valuable things as he did in the past.

### SECTION 3 Colloquial language

***a hell of a lot of jewellery*** (page 62)

an extremely large amount of jewellery.

***be in touch*** (page 24)

this means, I will speak to you on the phone. See also *get in touch* (page 37). This means, If you phone me, we will be able to have a discussion. These phrases mean the same as *to be/get in contact* with someone.

***get down to business*** (page 62)

this means, Shall we start talking about our business?

***get rid of*** (page 50)

this means, I'm going to drive Colin's car away from the house and leave it somewhere where it will only be found after a long time.

***go missing*** (page 46)

disappear.

***I'd better be going*** (page 14)

this means, I must leave now or I will be late.

***mates*** (page 19)

friends.

***sort out*** (page 11)

find answers to the problems on the computer software.

***What's your game?*** (page 9)

this means, What trick are you trying to play on me? John thinks that Linda is being too friendly towards Colin.

***Where the hell is he?*** (page 44)

Julie is nervous and worried because she hasn't been able to speak to Colin. This strong way of speaking shows her feelings.

### SECTION 4 General

***abandoned*** (page 47)

left someone or something without telling anyone where you were going.

***accent*** (page 6)

the way you speak English. John Bentley comes from south-east London. He speaks with a *soft London accent*.

***appreciate*** (page 66)

be very grateful for the things someone has done.

***attack*** (page 92)

the time when the Bentleys tried to injure and kill Mark and Julie.

***attend an inquest*** (page 37)

when someone dies suddenly, an official has to find out how and why they died. This is called an *inquest*. People who knew the dead person, or were present when they died, go to a special meeting. They *attend an inquest* and an official asks them questions.

***boot*** (page 29)

the place behind the rear seats of a car where you can carry things.

***breakdown truck*** (page 36)

a powerful truck which pulls vehicles that have been in an accident, or which cannot be driven, to a garage to be repaired.

***car jack*** (page 74)

a tool used to lift a car from the ground when you want to change the tyre on one of its wheels. A *car jack* has a long handle which you push up and down to lift the car.

***claim*** (page 95)

Linda Bentley has gone to a court of law in Spain and said that her aunt has died. She has told the court her real name and said that she should have her aunt's money. She has made a *claim*.



**common** – had something in common (page 16)

neither John nor Linda's parents were alive when they first met each other. The thing that they *had in common* was that they were both orphans. This phrase can also be used for people who have the same interests and like the same kind of things.

**connect** – connect that with (page 41)

Linda is saying that nobody will think about a funeral for John Bentley and believe that it has anything to do with a man called Colin Fenton, who has disappeared.

**contacts in the jewellery trade** (page 63)

Frankie knows many people who buy and sell jewellery. These *contacts* help criminals to buy and to sell stolen jewellery or they give criminals information about jewellery in shops.

**cutting equipment** (page 33)

machines which can cut through strong metal.

**display cabinets** (page 78)

large cupboards with glass tops which are used to show the goods that are for sale in a shop.

**disturb** – sorry to disturb you (page 39)

the police officers are saying that they are sorry to come to Linda's house late at night.

**emergency services** (page 33)

organizations which help people who are in trouble or in danger. The three main emergency services are Fire, Ambulance and Police. In Britain, you can ask for help from the emergency services by phoning the number 999. A *fire crew* (page 33) travel in a *fire engine* (page 35). Fire crews help people who cannot escape from vehicles, buildings, rivers etc. They put out fires. They also use *cutting equipment* (see above). An *ambulance* (page 33) is called for when someone is ill and has to go to hospital. *Paramedics* (page 35) travel in ambulances. They help injured people. A *stretcher* (page 36) is used to carry an injured person to and from an ambulance. The *police* (page 31) stop people breaking laws, they arrest criminals and help people who are in trouble.

**exit** (page 29)

the place where you can leave a motorway and drive onto smaller roads.

**flirting** (page 9)

behaving towards someone in a way that shows you like them very much.

**foot passengers** (page 91)

passengers who walk onto a ferry boat. They are taking a journey across the sea without a car, a bus, a coach or a truck.

**frost** (page 23)

hard, white ice which covers everything – roads, vehicles, buildings, grass, trees and plants – when the weather is very cold.

**funeral** (page 41)

the ceremony that takes place after someone dies. People who die are either *cremated* (page 51) or *buried* (page 84) in the ground. When a dead person is cremated, the body is burnt and the only thing that is left is soft dust – *ashes* (page 51). The *cremation* takes place in a building called a *crematorium* (page 51). The relatives of the dead person sometimes have the ashes *scattered* (page 51). This means that the ashes are put on the ground or sometimes, onto water. Relatives often like to scatter the ashes in a place that the dead person enjoyed visiting.

**fussy** (page 28)

want work to be completed in a particular way. Someone who is *fussy* likes everything to be tidy and correct.

**getting to know each other** – spent time getting to know each other (page 20)

talked together and found out about each others' lives and what they like and dislike.

**identify the body** (page 37)

go to a hospital or a police station to look at the body of a dead person and say who they are and where they lived. This is called *identification* (page 37). It is usually relatives who are asked to identify a body. Someone's *identity* (page 48) is the information about their name, age, address, their family and what sort of person they are. This information is kept in official records, together with details about their health and the money they have paid to the government for taxes.

**involved** – to be involved with (page 82)

know and work with someone.

**junction** (page 30)

the place where you can get onto or leave a motorway.

**lay-by** (page 29)

a place where vehicles can stop beside a road.

**lined with** (page 9)

there are shops along both sides of the road.

**mass** – a mass of torn metal (page 33)

the car has been so badly damaged that it just looks like a huge piece of metal.

**officially dead** (page 53)

when someone is *officially dead* the date of their death is put on that person's tax records, medical records and personal documents.

**out of control** (page 32)

the driver of the car cannot keep the car travelling safely on the road. The car is *out of control*.

**Passport Authority** (page 86)

the government department that prepares passports for British people who want to travel from Britain. All the information given on a passport must be correct or this official document is not legal. Relatives inform the Passport Authority when someone in their family dies, so that the passport is cancelled.

**picked one at random** (page 57)

Julie takes a CD quickly, without looking carefully at it.

**proposal** (page 20)

suggest to someone that you do something together. Colin had been expecting a *proposal* from Linda that they should make love together.

**put the car into reverse** (page 89)

Mark moves the gear controls of the car and drives it backwards.

**puzzled** – to look puzzled (page 56)

the expression on your face when you do not understand something.

**reaction** (page 70)

the way you behave when you hear good or bad news. Your reaction could be happiness, sadness, fear, shock or anger.

**receipts** (page 82)

pieces of paper that you are given when you buy goods or services. The *receipt* shows how much you paid for the goods or the services, and when you bought them.

**rented** (page 17)

a house that does not belong to the person who lives there. The agreement between the owner and the person who *rents* the house is called a *lease*. When the person no longer wants to live in that house, the *lease is cancelled* (page 53).

**risk** – know what risk I'll be taking (page 23)

Colin wants to know how serious the crime is that John and Linda are planning. He wants to know if he might go to prison, if they are caught by the police.

**roadworks** (page 32)

the place on a road or a motorway where workmen are using machines to repair it.

**second year running** (page 12)

for two years, Colin's company has not earned enough money.

**self-control** (page 60)

a person with *self-control* waits and thinks carefully before they do anything.

**service area** (page 29)

the buildings at the side of a motorway where you can stop and eat a meal in a restaurant or buy fuel for your car.

**sideboard** (page 19)

a long cupboard in a dining-room where glasses, plates, knives, forks and spoons are usually kept.

**sign a statement** (page 37)

when there is an accident or a crime, police officers ask people who have any information to write down a *statement*. This gives details of everything that the person knows about the crime or the accident. The person then *signs the statement* to show that everything they have written is true.

**steel shutter** (page 75)

a strong metal cover that is pulled down over the doors and windows of a shop or a building in which valuable things are kept.

**suburbs** (page 5)

the area outside the centre of a city.

**sympathize** (page 50)

listen to someone's troubles and tell them that you are sorry that these things have happened.

**taking aim** (page 89)

John is carefully pointing a gun at Mark because he is going to shoot him.

**wallet** (page 15)

a leather container for holding banknotes.

**witnessed** – to be witness to (page 32)

the person who sees an accident happen has *witnessed* an accident. The police may ask the *witness* to describe what happened – give a statement. Later, the person may have to go to a court of law and say what they saw.

**Yellow Pages** (page 15)

a British reference book which gives addresses and phone numbers for businesses and services.
